## Introduction

---

Proposal Development is by far Streamlyne Research's most popular and complex module. The content herein will help shed some light on the use and functionality of this module.

### Foundational Concepts in Proposal Development

The Proposal Development (PD) document aka Development Proposal is intended to record all institution, sponsor, and project information for any application your institution is submitting for external funding. The data entered on the PD is validated, routed for workflow approvals, and submitted to the sponsor. The submission event marks the end of Proposal Development processes.

#### Grants.gov/S2S vs. Non-Grants.gov/External Submissions

The manner in which a Proposal Development document is submitted can be system-to-system (S2S) or non-S2S. At the time of this writing, the only proposal submission portal that allows S2S integration is Grants.gov.

S2S submissions required that all PDs be prepared according to standards set by the portal, Grants.gov. This requires more data entry than non-S2S submissions. This also requires adherence to rigorous validation rules, which vary depending on the federal forms required for the submission.

When preparation is completed, transmission to Grants.gov happens when:

1. The submission passes all validation rules enforced by Streamlyne, to include Grants.gov validations.
2. The submission is entered into workflow by clicking the Submit button.
3. The user clicks the Submit to S2S button.

Non-S2S submissions require that all PDs be prepared according to your institution's unique business rules. Generally, these business rules represent the minimum data requirements from Streamlyne as well as the proposal data your institution would like to report from.

In parallel and outside of Streamlyne, the preparer must complete the submission according to the sponsoring agency's guidelines, which can be on paper, via email, directly to a proprietary online portal, etc. Because these submission options are external to Streamlyne, the preparer can upload a copy of the final submission to the PD document. The preparer then clicks the Submit to Sponsor button to mark the submission as transmitted.

## Concurrent Users

Because a PD will most likely be completed by multiple users, Streamlyne Research supports three concurrent users per document any time, but never more than one user per section to avoid data conflicts. Three separate users may concurrently update the Proposal's core data elements, the narrative elements on the Abstracts & Attachments tab, and the Proposal Budget tab, respectively.

## Permanent Record of Each Submission Attempt

The Proposal Development document is designed to be a permanent and auditable record of each submission attempt. Given this, it is very important to note the following:

- There can be many PDs/submission attempts for any given competition/opportunity.
- A PD is finalized when the last person in the approval chain approves the document, or when the Submit to Sponsor/S2S button is clicked, whichever comes first.
- A PD, once finalized, is uneditable.

## A Stepwise Approach

This guide is designed to facilitate immediate productivity for new users in a complex and unfamiliar system. To achieve this end, the processes are broken down into manageable chunks with the steps to each process laid out sequentially.

By practicing the steps and experimenting in the application at the detail level, you will gain the knowledge you need to design high-level processes that meet your institution's unique needs.

## Every Installation Is Different

Streamlyne Research is highly configurable. During the implementation process at your institution, it is likely you will perform some level of analysis to identify which features you would like to use, which values you would like to change to reflect your institution's terminology, and which features you will skip altogether.

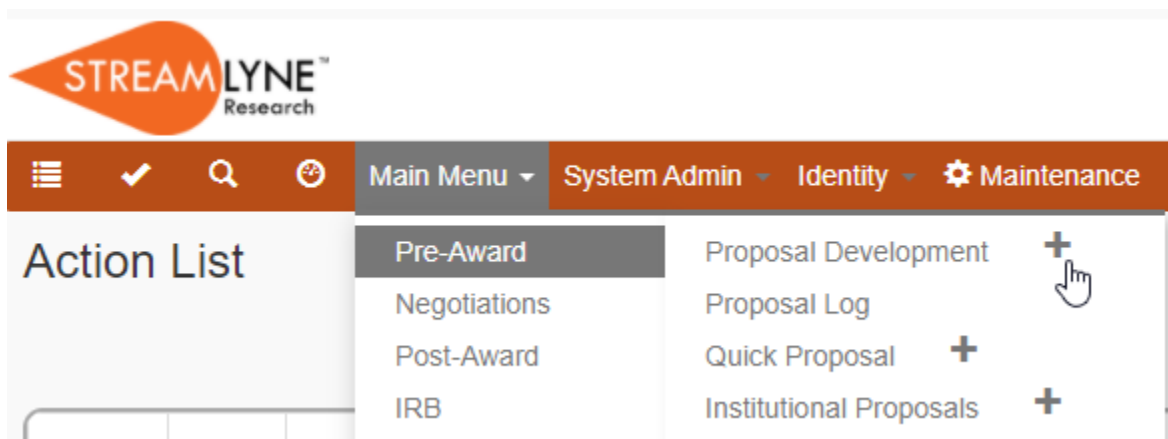
Given this, the processes detailed in this document are representative of general practices and do not necessarily represent the exact manner in which your institution will choose to use the application.


## Initiating a New Development Proposal

Every PD is initiated with the same three steps: you must navigate to the “create” button, you must enter the minimum fields required for saving, and you must click the Save button. A record of your document will not exist in the database until three steps are completed.

All transactional documents are created by clicking the Plus Sign associated with the menu option. Follow this navigation to initiate a new PD:



## Minimum Required Fields for Saving

Follow these steps:

1. Initiate a new document by navigating to Main Menu > Pre-Award > Proposal Development > +.
2. Complete the Minimum Fields Required for Saving outlined above.
3. Save your work by clicking the Save button at the very bottom of the page. 

**Note** Once the document is saved, it will remain on your Action List as a pending item with a COM symbol, prompting you to complete the document at your convenience.

The document will remain on your Action List as a COM item until you or a collaborator submits it into your institution's predefined routing path, aka workflow.

# Setting Up an S2S Proposal

---

Skip this section if:

- Your institution has chosen not to use S2S functionality, **or**
- You are not applying to a Grant.gov opportunity.

## Overview

Streamlyne Research's S2S functionality is designed to seamlessly populate both mandatory and conditionally required forms using the data collected in the Proposal Development document and in linked tables such as Person, Person Extended Attributes, Sponsor, Organization, Address Book, Unit, and Unit Administrator. All incoming opportunity data, outbound submission data, and inbound submission validation data is transmitted via XML messaging, bypassing the PDF package or the Grants.gov Workspace.

There are certain forms for which no equivalent data can be collected and stored in Streamlyne. These are called User Attached Forms. For these forms, the user must download the unstitched form from the linked library, fill it out, and attach it to the User Attached Forms panel so that the PDF data can be converted to XML and transmitted with the rest of the package.

## Prerequisites

There are two prerequisites to setting up a PD for S2S submission:

1. A PD must exist in the database, which we covered in the last section. Complete the Required Fields for Saving section if you have not already.
2. The Sponsor you selected in the previous step must be correctly configured with a Sponsor Type of Federal.

If you know your Sponsor ID is correct, but the S2S tab is greyed out, it means the Sponsor record is incorrectly configured.

- If you are feeding sponsor data from an external source system via ETL, the data must be corrected in the source system and new file generated to fix the Sponsor record.
- If you are maintaining data manually, correct the record in Main Menu > Settings > Sponsors.

## Stages in S2S Setup

There are three stages to setting up a PD for preparation and eventual S2S submission:

1. You must link your opportunity to the PD on the S2S tab.

- Using the opportunity instructions, you must select the optional federal forms to include in the submission package.
- You must identify and access all unstitched User Attached Forms required for your submission.

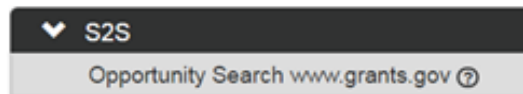
## Linking an Opportunity to the Proposal Development Document

Follow these steps to add a Grants.gov opportunity a proposal:

- Click the S2S tab header to access the tab.



- Do you know your opportunity ID or CFDA number? If not, click the hyperlink to access the Grants.gov site to find these values.



- Click the magnifying glass icon next to the S2S Lookup field label.

Do you need to submit any of the forms that are Not Available? If so, follow these steps to download the unstitched user attached form(s):

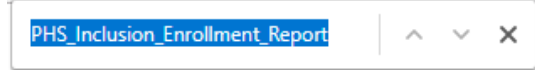
1. Doubleclick on the name of the form filename to highlight it. 
2. Click Ctrl + C (or rightclick > Copy) to copy the form filename.



3. Click the Grants.gov Forms Directory hyperlink on the right side of the grey titlebar.
4. Streamlyne takes you to the Grants.gov Forms Directory in the Streamlyne Resources library.

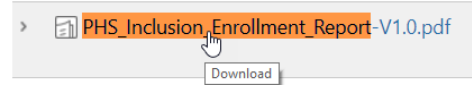
Click Ctrl + F to bring up a Find window within your browser.

5. Click Ctrl + V, or rightclick>Paste, to paste the filename in the Find window, then Enter.



6. The browser's Find feature will take you to the link to the form.

Click the hyperlinked form filename to download the form.



7. The form is then downloaded to your browser. At this point, save the form to a place that makes the most sense according to your role and/or business process so that the proposal preparer, if not you, will have access to the form to fill out later.





1. Click the header to expand the Sponsor & Program Information section.
 


2. Click the arrows next to the optional **Sponsor Deadline Type** field, and then select the correct type from the list.
3. Click the arrows next to the optional **Notice of Opportunity** field, and then select the type of opportunity from the list.
4. The **Sponsor Name** field will auto-populate.
5. The **CFDA Number** field will auto-populate if the Proposal has been linked to a Grants.gov opportunity, and that opportunity has a CFDA number. If this is the case, skip to the next step. Otherwise, enter the **CFDA Number** in the format NN.NNN.
6. Add an **Internal Deadline Date** if necessary.
7. A **Prime Sponsor** is the organization from which funds will originate if that organization differs from the **Sponsor**. For example, if your institution is applying for a subaward from another institution as federal pass-through funding, then the Sponsor is the institution that will grant the subaward, and the **Prime Sponsor** is the federal sponsor where the funds will originate. If your institution is applying as a subrecipient, select a **Prime Sponsor ID**, click the magnifying glass  to search for and select the correct value.

8. If the Proposal has been linked to a Grants.gov opportunity, then the **Opportunity ID** field will auto-populate accordingly. If this is the case, skip to the next step.

Otherwise, enter the optional **Opportunity ID**, if there is one, for the Proposal.

9. To indicate the field of research activity, click on the arrows next to the **NSF Science Code** field, and then select the correct code from the dropdown list, if applicable.

Entering this code can help when your institution is compiling data for the NSF annual survey or other reporting.

10. If the sponsor has assigned a Proposal ID, enter this in the **Sponsor Proposal ID** field. Usually, this ID is available when a proposal is resubmitted or revised.
11. If you are developing a proposal for the National Science Foundation, enter the 3 letter **Sponsor Division Code** assigned to the NSF Division to which you are applying. This is required for S2S submissions to NSF.

12. If the Proposal includes subrecipients, click the checkbox for **Does this proposal include Subrecipients?**

13. Click the arrows next to the **Anticipated Award Type** field and select the type of funding agreement expected for the Proposal.

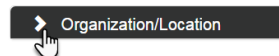

1. Click the header to expand the Organization/Location section.



- The **Application Organization** defaults to the institution associated with the Lead Unit. This is critical for S2S submissions because the DUNS configured on the Organization record linked here will populate to the S2S forms.


If you have to switch Application Organizations, click the magnifying glass to search for and select the correct value.


2. The **Performing Organization** also defaults to the institution associated with the Lead Unit.

If a different organization will be performing the work, click the magnifying glass 🔍 to search for and select the correct value.

3. If applicable, further specify where the work will take place by listing specific sites in the **Performance Site Locations** you have preconfigured in the Address Book.


If this does not apply to your Proposal, skip to step 5.


To add a new site, click the magnifying glass  to search for and select the correct value from the Address Book.

4. Click the Add button to complete the action. 

Repeat Steps 3 and 4 until all sites have been added.

5. If applicable, list any organizations that will be affiliated with the project in the **Collaborators** section. This could include collaborating institutions and subaward locations. If this does not apply to your Proposal, skip to the next process.





To add another organization, click the magnifying glass  to search for and select the correct value.

6. Click the Add button to complete the action.

The Congressional Districts subsection will appear for each address listed in the Organization/Locations section of the Proposal tab.

1. Click the Show button next to the Congressional Districts subsection you wish to review or edit.



2. The congressional district for the address will default if it is configured to do so at your institution.




2. Indicate whether the proposal package will be mailed by the department or by the Office of Sponsored Projects by selecting the appropriate value from the **Submitted By** dropdown list.
3. Click the arrows next to the **Type** field and select the delivery method from the dropdown list.




## Updating the Key Personnel Tab

On the Key Personnel tab, you identify the Principal Investigator (PI) for the project being proposed as well as any other Co-Investigators (Co-I) or Key Persons who will contribute significantly to the project.

At a minimum, all proposals must have one PI identified on this tab in order to be considered valid.


## Adding Key Personnel to the Proposal

1. Click the tab header to access the Key Personnel tab. 
2. In the Add Key Person section, you can search for and select people to add to the Proposal. Identify the project key person by clicking the magnifying glass  to look up the **Internal User Name** (Employee) or **External Address Book ID** (Non-Employee).
3. Click the arrow next to the **Proposal Role** field to select the key person's role from the dropdown list. 

**Note** A Proposal must have one and only one person with the PI/Contact role. Additional investigators can be added as Co-Investigators.

If your proposal is being submitted to the National Institutes of Health (NIH), the system will display a Multiple PI checkbox when a key person is identified as a Co-Investigator. Click the box to check or uncheck the **Multiple PI** indicator.

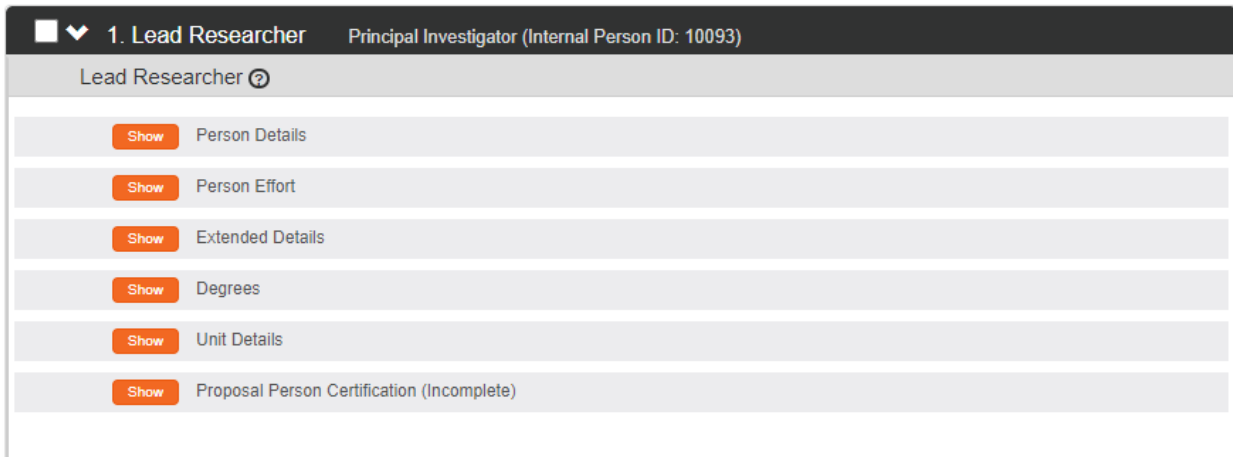


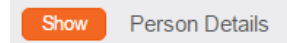


For each Key Person added to a Proposal, Streamlyne Research provides the ability to view and update detailed information in a series of attributes subsections. Much of the Key Person's data is auto-populated from Person tables and Person Extended Attributes tables. Auto-populated data can be modified or added as needed in these subsections.

Note that changing the data for a Person within the Proposal will change that data only for this Proposal and will not overwrite the source data in the configuration tables.

If you are submitting S2S, many fields here map the PI information fields on federal forms. If you are not submitting S2S, follow your institution's guidelines for filling out this section. For non-S2S submissions, you may find it most useful to focus on capturing the contact information and the percent effort for people on the Proposal.

2. The **Proposal Person Role Id** displays the Role selected when the Person was added to the proposal. For the PI and Co-Is on the Proposal, you can click on the arrow to select a different role from the list.

It may be the case that project personnel submit research proposals under a name that differs from their current legal name. If this is the case, update the **First Name**, **Middle Name**, and **Last Name** fields with the name used by the Proposal Person for submissions.

If such a change is made, you will need to delete the person from the Proposal, and then add the person again for the correct **Secondary Office Location** to appear on the Proposal document.

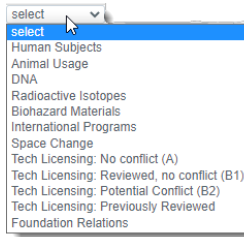

## Updating the Abstracts & Attachments Tab

This section acts as a repository for the narrative attachments that support or describe aspects of the proposed project. Streamlyne Research allows for concurrent users in the Proposal document specifically to allow one user to update the Abstracts & Attachments tab while another is working in the Proposal tab. The optional Proposal Budget document allows you to work up versions of a proposed budget to explore various what-if scenarios during the development of the Proposal. Prior to review and approval, one budget must be selected as the final version that will be submitted to the sponsor.



1. The **Project Start Date** and **Project End Date** display the project dates from the Proposal. This date can be changed from the Proposal tab.

Changing the dates on the Proposal tab may require additional changes to the Budget to accommodate those date changes. Error and warning messages will indicate where data needs to be updated within a Budget to address changed start or end dates.

2. Click the **Modular Budget?** checkbox if the Budget is for an NIH opportunity that accepts funding requests in the modular format (e.g., \$25,000 increments up to \$250,000 per year).
3. Enter **Residual Funds** to document any funds remaining from previous awards.
4. Entering a **Total Direct Cost Limit** sets the maximum funding amount (excluding indirect costs) that will be requested from the sponsor in the Budget. Leave this field blank to create a Budget without a pre-set limit.

When an amount is entered in this field, warning messages will display if the direct costs in the Budget exceed this limit.

5. Entering a **Total Cost Limit** sets the maximum funding amount (including direct and indirect costs) that will be requested from the sponsor in the Budget. Leave this field blank to create a Budget without a pre-set limit.

When an amount is entered in this field, warning messages will display if the total costs in the Budget exceed this limit.

6. Click the **Final?** checkbox to indicate that this Budget is the version that will be submitted to the Sponsor.

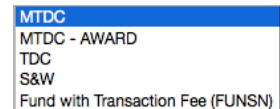
Once the Budget has been marked both Final and Complete, the **Final?** checkbox becomes read-only. To make the checkbox editable, make sure the **Budget Status** is set to Incomplete.

The Budget Periods & Totals section holds summary budget data for the Proposal Budget period(s). Budget Periods are initially established using the Project Start and End Dates entered on the Proposal. From this tab, you can adjust the Budget Periods as necessary as long as the dates fall within the Project Start and End Dates.

In this section, you can also create a simple summary Proposal Budget by entering values in the fields for each Budget Period. Enter summary budget amounts here if you will not be creating a detailed budget.

**If the default periods are appropriate and you plan to create a detailed budget by entering in personnel and non-personnel costs, you can skip this section entirely.** The system will populate the summary data automatically based on the detailed budget expenses you will add later on the other tabs.

Follow these steps to update the budget periods and/or create a simple budget in the Budget Periods & Totals section:

1. Click the header to expand the Budget Periods & Totals section.

**Note** The system will default to display the Budget Period(s) based on the Project Start/End Dates, automatically assuming a 12-month project period duration. The default periods can be modified, or new periods can be added as needed.

Budget periods cannot overlap. Make sure to review project period start and end dates to prevent an overlap of days across periods.

2. The **Period Start Date** represents first day of the budget period. If the defaulted date is acceptable or if you are not adding a new budget period, skip to the next step.

Otherwise, enter this date in MM/DD/YYYY format or click the calendar icon to select the date from the calendar.

**Note** The **Period Start Date** for the first budget period must be equal to or later than the Project Start Date, and the **Period End Date** for the final budget period must be equal to or earlier than the Project End Date.

3. The **Period End Date** represents last day of the budget period. If the defaulted date is acceptable or if you are not adding a new budget period, skip to the next step.

Otherwise, enter this date in MM/DD/YYYY format or click the calendar icon to select the date from the calendar.

**Note** Do not enter a value in the **Total Sponsor Cost** field. This value will be calculated automatically whether you are entering direct costs and F&A costs to this section to create a summary budget or entering detailed expenses to develop the budget.

4. If you are entering budget detail to the Personnel and Non-Personnel tabs, the system will automatically calculate the **Direct Cost**. Skip to Step 8.

Otherwise, enter the direct cost limit as a dollar value in the **Direct Cost** field.

5. If you are entering budget detail to the Personnel and Non-Personnel tabs, the system will automatically calculate the **F&A Cost**.

Otherwise, enter the facilities and administrative cost as a dollar value in the **F&A Cost** field.

6. If you are entering budget detail to the Personnel and Non-Personnel tabs, the system will automatically calculate the **Unrecovered F&A**.



Otherwise, enter the unrecoverable facilities and administrative cost as a dollar value in the **Unrecovered F&A** field.

7. If you are entering budget detail to the Personnel and Non-Personnel tabs, the system will automatically calculate **Cost Sharing**.


Otherwise, enter the cost-sharing amount as a dollar value in the **Cost Sharing** field.

8. If you want to be able to default detail budget line amounts based on the cost limit (direct plus indirect), enter the total cost limit for the budget period in the **Cost Limit** field.

Otherwise, skip to the next step.

9. If you want to be able to default budget line amounts based on the direct cost limit, enter the total direct cost limit for the budget period in the **Direct Cost Limit**.  
Otherwise, skip to the next step.
10. To add a new budget period to the summary, click the Add button.   
Otherwise, click the Save button at the bottom of the page to update your changes.
11. Repeat Steps 2 through 11 until all budget periods are included on the budget document.
12. If necessary, click the Delete button to remove any budget periods that were created in error.
13. Click the Calculate All Periods button to update the totals. 



### Parameters Tab > Generate All Periods Button

If you are working with a multi-period budget with detailed costs, the Generate All Periods button at the bottom of the page will copy all expenses from Budget Period 1 to subsequent budget periods. 

Do not click this button until all Period 1 costs are entered on the Non-Personnel and Personnel tabs.

Skip to the next process if the Non-Personnel and Personnel costs have not yet been completed for Budget Period 1. You will be referred back this section at the end of the chapter dedicated to Non-Personnel costs, as detailed here: Parameters Tab > Generate All Periods Button.

Once Personnel and Non-Personnel costs are added to initial period in the Proposal Budget, follow these steps to copy costs from Budget Period 1 to all subsequent periods:

1. Click the Save button to ensure that the most current budget data will be used in the copy. 
2. Click on the Generate All Periods button at the bottom of the page. 

**Result** Budget costs will be added to all subsequent periods. These costs will be inflated where appropriate. You can edit, update, or delete the copied data for each period on the Personnel and Non-Personnel tabs.

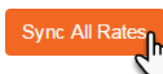
### Updating the Rates Tab

The options on the Rates tab are dependent on the Rates configuration for your institution. The sections on this tab display these configured Rates grouped by class. Within each rate class section, you have the ability to optionally override the percentage values where rates for the Proposal differ from institution-wide default rates. The institution-wide default rates are called **Institute Rates**, and the rate that applies to the Proposal is called the **Applicable Rate**.

Each time rates are modified on this tab, the budget will recalculate and apply the updated rates. Further, when **Applicable Rates** are less than **Institution Rates**, Streamlyne Research will recognize the discrepancy and calculate the **Cost Share** or **Unrecovered F&A** amount for the budget period accordingly.

### Rates Tab > Syncing All Rates

When a Proposal is created by copying an earlier Proposal, it is possible that the copied rates differ from the current rates configured at your institution. To ensure you are always working with the most current rates, click the Sync All Rates button at the bottom of the Rates tab to update the Proposal Budget document with the latest Institute Rates.





### Rates Tab > F&A Section

The title of the F&A section reflects the Activity Type selected on the Proposal, for example, “Research F&A” or “Clinical Trial F&A.” This section displays the default F&A rate types set up for your institution that are effective for the Proposal Activity Type during the fiscal year(s) covered by the Proposal Budget.


Calculations using the F&A rates set up in this section will be applied automatically to line-item costs on the Personnel and Non-Personnel tabs, taking into account other factors, including Object Code Type, Unrecovered F&A Rate Type, Overhead Rate Type, and Activity Type.

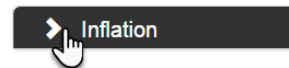

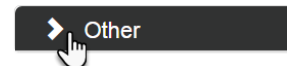

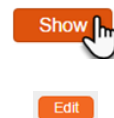

## Updating the Personnel Tab

All budget expenses related to project personnel are managed on the Personnel tab. Click the tab header to access the Personnel tab. 

Note that the tab view defaults to the first period for multi-period budgets. To work with a different budget period, click the dropdown list next to the **Budget Period** field and select the date range with which you wish to work. Then, click the Update View button to update the data on the page.









1. Click on the section header to expand the Project Personnel (All Periods) section.





2. Streamlyne Research initially populates this section with all named personnel from Key Personnel tab on the Proposal document.

It may be the case that additional personnel are added to the Proposal document after this section is initially populated. When this situation occurs, you must manually trigger the data sync to pull those personnel into the list.


Click the Sync Personnel button to ensure all named personnel on the Proposal also appear on the Project Personnel (All Periods) panel in the Proposal Budget document.



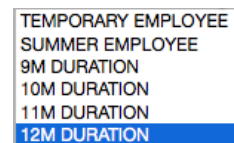
3. To add additional personnel to the budget, click the magnifying glasses  to search for and select **Employee** and/or **Non-Employee** person records.

Alternatively, if you know the project will require hiring or appointing new personnel, click the **To Be Named** magnifying glass  to the search for and select the position name that will be filled at a later date.

4. For each named personnel or position, the system populates as many fields as possible based on the completeness of the configuration in the corresponding Person or Job records.

It may be necessary to manually populate the **Job Code** for a given row by clicking the magnifying glass  to search for and select the **Job Code**.

5. Click the arrows next to the **Appointment Type** field, and then select the appropriate value from the dropdown list.



6. Streamlyne Research populates salary data for named personnel where it is available in the Person records.

For positions where personnel have yet to be named or for named personnel without salary data in Streamlyne Research, enter the salary amount that will be budgeted for the position in the **Base Salary** field.

7. For personnel added to the budget, Streamlyne Research populates the Project Period Start Date to the **Salary Effective Date** field. This date can be modified for each person as needed.

8. Streamlyne Research populates the **Salary Anniversary Date** for named personnel if the data is available. If cost-of-living increases are budgeted for this Proposal using an **Inflation Rate**, this increase will take effect on the Salary Anniversary Date.

If this date is not populated, identify it by entering the date in MM/DD/YYYY format, or by clicking the calendar icon to select the value.


If no date is entered in this field, the budget will calculate inflation based on the default inflation date set up by your institution unless you manually set a base salary for the person as described in step 9.


9. For Proposal Budgets with multiple periods, you can manually set a person's salary for each Budget Period. This is useful when you know that a project person will have a non-standard increase in salary between one period and the next.

## Personnel Tab > Project Personnel (All Periods) Section > Sponsor Salary Cap

Streamlyne includes the ability to apply a Salary Cap to project personnel whose salary rate exceeds a defined salary cap. When enabled, the Sponsor Salary Cap value is populated with the default value from the configuration parameter. This value may be overwritten if necessary, prior to applying to any budget person's salary.

In order to apply the salary cap to all budget personnel, click the **Apply Salary Cap** button.

**Apply Salary Cap** Once selected, Streamlyne will adjust the Base Salary Rate with respect to the duration of the Appointment Type to the value in the Sponsor Salary Cap field.

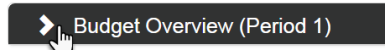
In the example above, the \$250,000 salary for the PI/Contact was adjusted to the \$199,300 Sponsor Salary Cap and a green indicator is displayed to indicate this action. To remove the salary cap limitation, click the Reset Default Salaries button to return the Base Salary to their original values. **Reset Default Salaries**

As another example, if the \$250,000 Base Salary was associated with a 9-month Appointment Type, then the Base Salary would have been adjusted to  $(9/12) \times \$199,300$  or \$149,475 because this is the 9-month salary that would represent an annualized value of \$199,300. Once these Base Salaries are adjusted, Streamlyne will apply any configured inflation rates in subsequent budget periods. If you want to disable inflation for individuals who exceed the Sponsor Salary Cap, you can turn off inflation for specific Object Code in the subsequent budget years.

## Non-Personnel Tab > Using Formulated Costs

Streamlyne can be configured to use standard costs for specific object codes and applying them to specific quantities within a budget. This can be useful for calculating travel expenses for example, if the budget included two people traveling to a conference for 4 days and your institution had a standard cost of \$50 per day per person as a per diem expense, Streamlyne could be configured to calculate the line-item cost of \$400 by entering '2' persons for '4' days. Another use for this functionality could be in the cost-per-use for specific high-tech equipment.

In the example below, streamlyne has a standard price for a Laptop computer.

When an Object Code is added to a budget, and that Object Code is configured for Formulated Costs, the item can be added to the budget with a \$0 Total Base Cost.

In this simple example, Streamlyne calculates the expense for the two computers and populates the Total Base Cost of the item automatically. For any single Object Code, the Total Cost of that item may include as many Formulated Cost Details as needed.

For a single 'Travel Expense' Object Code for example, there could be multiple Formulated Types to build the Total Base Cost for that single Object Code. There could be: Air Travel, Lodging, Transportation, Per Diem, Conference Registration for example. Each item would have its own Unit Cost, Count and Frequency, and the Total Base Cost for that single Travel Expenses Object Code would be automatically calculated from the Calculated Expenses of each Formulated Cost.

- Click the Turn Off Validation button to continue working on the Proposal Budget without the system running validations to check for errors or missing data. [Turn Off Validation](#)

7. Once the budget version has passed validation, and it has been identified as the budget version that will be submitted to the sponsor, you can identify this budget as Complete and Final.

Follow the instructions in steps 6 and 7 in the 8.2.1 Parameters Tab > Budget Overview Section to complete the budget before the Proposal can be submitted into routing for approvals.



## Submitting for Initial Review

Proposals may be 'Routed for Review' prior to being submitted into workflow for review and approval. This pre-submission review is intended to give central office, or departmental, administrators an informal review of a proposal before it is submitted formally into workflow.


Once Routed for Review, the Document Status changes to 'Submitted for Review'. The proposal is locked to prevent editing, other than specific portions of the proposal which can be configured for your institution.



Once submitted for review, all of the users who have the Initial Reviewers role will receive an Action List notification. Any of the Initial Reviewers can then access the proposal and assign the proposal to a specific person within the group who will be responsible for its Initial Review.


The Assigner Reviewer will then make a determination that the proposal is complete and ready to be submitted into workflow or will return it for corrections. Any observations or notes may be entered on the Notes panel within the Abstracts & Attachments tab.

## Routing a Proposal for Initial Review


Follow these steps to route a Proposal for initial review:


1. On the Proposal Actions tab click the Route for Review button.  This action will initiate Action List notifications to all Initial Reviewers and the proposal will close.
2. An Initial Reviewer (a user with the appropriate role) finds the proposal in his/her Action List and opens the proposal.








3. Notice that the Document Status has changed: **Document Status : Submitted for Review**
4. Click on Proposal Actions tab 

5. Click on Review Assignments panel 
6. Within the Review Assignment panel, select the Reviewer from the Assign/Change Reviewer drop-down list.



7. Click Assign Reviewer . Initial Reviewers may assign themselves or any others who are in the list. Initial Reviewers can also change the Assigned Reviewer at any time.
8. Once Assigned, the Document Status changes to Under Review. 
9. The Reviewer now reviews the proposal, makes any comments in the Notes panel on the Abstracts & Attachments tab. Once the review is complete, the Reviewer navigates to the Proposal Actions tab and chooses either Review Complete,  indicating the proposal is acceptable and ready for submission into workflow or Return for Modifications,  indicating the proposal needs modifications prior to submission into workflow.
10. The proposal is returned to the initiator and is open for editing. The document status is modified again to reflect the Reviewer's determination. 
11. The Initial Review process can be iterative and may be repeated as many times as necessary prior to submitting into workflow.

## Submitting & Approving

---

When data entry and budget development for a given Proposal document is complete, the document is ready for submission, review, and approval.

### Submitting a Proposal into Workflow

Follow these steps to submit a Proposal into your institution's workflow for review:

1. Open the Proposal you wish to submit.
2. Click on the Proposal Actions tab.

3. Click the Submit button at the bottom of the page.

**Result** The PI will receive an APP item on his or her Action List to prompt them to perform a Proposal Review.

## Submitting a Proposal to the Sponsor

If you are following best practice, a proposal is submitted to a sponsor after it has been approved by all required reviewers in the approval workflow. This is generally a central office function.

There is not always time for best practice, however. The option to Submit to Sponsor/S2S becomes available as soon as a Proposal has been submitted into routing workflow. If a Proposal is submitted prior to collecting all approvals, the status will indicate “Submitted – Pending Approval” rather than “Submitted.”

In addition, submission prior to approval has the following consequences:

- The proposal is locked down from all edits normally available in workflow, to include Narrative Replacement and Proposal Data Override.
- If the already-submitted proposal is rejected for modifications in workflow, a subsequent PD must be created from the original, modified to rectify the reason for rejection, and resubmitted.
- If the already-submitted proposal is rejected outrightly in workflow, the submission must be withdrawn from the Sponsor and the companion Institutional Proposal updated to Withdrawn status.

Follow these steps to submit a Proposal to the grant’s sponsor:

1. Open the Proposal you wish to submit to the sponsor.
2. Click on the Proposal Actions tab.
3. If you are submitting S2S, click the Submit to S2S button. Otherwise, click the Submit to Sponsor button at the bottom of the page.

**Result** The Proposal Development document will be permanently locked for editing, providing a snapshot of the data submitted.

Simultaneously, the system will automatically create an Institutional Proposal document. From this point forward, any changes to the data resulting from negotiations with the sponsor (or for any other reason) will be captured in the Institutional Proposal document.

## Reviewing & Approving a Proposal

When a document is submitted into workflow, each approver will, in turn, receive an APP item on his or her Action List along with an accompanying email. If your institution has chosen to configure a serial workflow, then the second approver will not receive such a notification until the first approver has reviewed the document and rendered an APPROVE decision. Conversely, if the first approver rejects the Proposal for whatever reason, then the second approver in the chain will never be notified.

Alternatively, your institution may choose to have some portion of the workflow routing path configured to operate in parallel. This would mean that some (or all) of your approvers would receive notifications simultaneously.

Follow these steps to complete a review of the Proposal:

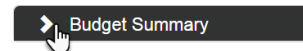

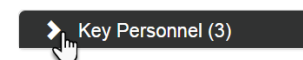

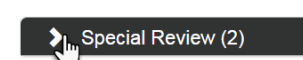
