

National Science Foundation

New PAPPG out (May 20)

- Common Forms required for Biosketch and Current and Pending (Other) Support
 - https://www.nsf.gov/bfa/dias/policy/nstc_disclosure.jsp
 - <https://www.youtube.com/watch?v=AAf34k4QrVE>
- Synergistic Activities now available on research.gov
- Mentor plans now required for graduate students, not just postdocs
- Individual Development Plan now required for postdocs with 1+ month of support

National Institutes of Health

New NIHGPS out (April 30)

- New salary cap - \$221,900
- Updates to Data Management and Sharing (DMS) plans
- Updates to certification and disclosure requirements
 - More project staff covered
 - Requires SciENCv form
- Common Forms will be required as of Jan 2025
- Terminology updates to align with UG, e.g. “prime recipient” to “pass through entity”

Air Force Research Laboratory (AFRL)

- Creating new PI portal for pre-proposals (i.e. white papers)
- Generic intake email addresses available on grants.gov for various program areas
 - PIs can initiate discussion with 3-5 page white paper
 - Program areas will share information as appropriate
- Pending fellowships focused on US-born scientists and engineers

Department of Homeland Security

New DHS Standard Terms and Conditions out (Nov 30, 2023)

- Reviewing systems and processes
- Push on social science research – trafficking, extremism, etc.
- Focus on translation to practice

USDA NIFA

- Updating systems – ezFedGrants, CREEMS
- NIFA Federal Assistance Policy Guide in review, expected Q4, 2024

NASA

Pending changes to GCAM (Oct, 2024)

- Will include/supersede Proposer's Guide
- Standalone Terms and Conditions
- New training video series is available

- NASA versions of Common Forms anticipated Oct 1, 2024
- Inclusion Plan proposal requirement is being piloted
- NCE request deadlines will start being enforced, must be requested online <https://www3.nasa.gov/centers/nssc/forms/grantcooperative-agreement-no-cost-extension-request>

Office of Management and Budget (OMB)

Uniform Guidance Updates, effective Oct 1, 2024

- Preamble to updates contains background on intent of revisions
- Changes to MTDC
 - Subawards increase from \$25,000 to \$50,000
 - Equipment increase from \$5,000 to \$10,000 (equipment disposition and excess supplies)
- Admin and Clerical Salaries no longer require prior approval
 - Still document allocability
 - All other standards apply
- DeMinimis rate increase from 10% to 15%
- Administrative costs associated with termination are allowable
- Childcare costs are allowable as Participant Support

Office of Management and Budget (OMB)

(Continued)

- Cost Principles “apply” to fixed price subs, but do NOT require cost reimbursement style invoicing or documentation
- Simplified Acquisition Threshold increased to \$500,000 (FP subs)
- Change in subrecipients requires prior approval ONLY if change in scope or subrecipient is named in award
- CAS Disclosure Statement no longer required for IHE
- Federal Program Inventory – fpi.omb.gov
- FFATA clarification is pending
- Prior approval request requires 30 day response from agency
- Reporting violations based on “credible evidence basis”
