**University Committee Reports** 

President Lay reported from the student experience task force | They discussed upcoming ideas for Res life and feedback from students regarding Res

Life. The Committee discussed health and wellness. The Counseling Center was a topic of conversation.

Budget Advisory | The 2 million deficit in budget was discussed – reallocation is not allowed to be shared, but will be common knowledge in June

Senator Wharton served as proxy for library committee | They discussed budgeting for publication resources for the library. The TBR has cut publication resource funding for higher education, so the committee has looked at the funding for the next few years and where they would like to make cuts.

Senator Wharton reported from Research & Advisory Committee | They discussed the scholastic research award, reviewed applications, and should have them awarded by next meeting.

There was no unfinished business

Senator Tidwell made a motion to suspend rules to add Constitutional Reform report to the agenda.

Motion was seconded and approved.

Constitutional Reform Committee – The committee reviewed Bylaw changes. The recommended changes have been reviewed. We reviewed an upcoming bill.

**New Business** 

Proposal of Bylaws from Constitutional Reform Committee

Reorganization. Exec cabinet and exec council are two different parts of the bylaws. Tab – committee meets to approve applications for funding.

Senator Perry asked for clarification on why the committee needs to be changed. The sponsor responded the changes help in selecting the artist we have, develop planning, and play a large part in the SOLO Events. Senator Perry stated as a member of the SOLO Committee, she feels it is not necessary.

Senator Tidwell wanted to clarify a few more things – solo committee currently does those things, but the executive order changes this process last year.

Senator Hagar yielded her time to Addison Dorris. Dorris stated the TISL director was listed in section 2 – not in section 3.

Friendly amendment.

Senator Perry asked where the play-by-play report they said they would provide is located.

Austin responded he did not feel it would be beneficial as the whole document would be red, there's nothing we didn't change. We took what we already had and reorganized it, so the whole formatting was changed.

Senator Tidwell – There is not substantive changes to the document. The main thing this changes; takes vague items and clarifies them, the change were very small. Tidwell stated they are wanting someone outside of SGA to be able to be run SGA.

President Lay addressed the floor stating his support of the document. He encouraged this document – the document you see in front of you is a beautiful version of the bylaws. They have done the exact job of what you commissioned them to do. The solo committee is the only substantive changes. The senators are disengaged. The operating manual of the organization. A document that is very easy to understand, outside people need to understand what the SGA does.

Senator Wharton stated the original version is in the SGA teams channel – you can see and compare the changes within the teams channel.

Senator Henderson shared appreciation for the bill but motioned to postpone the date of the bylaws to next SGA meeting due to the Senate only have one hour to review.
