

Minutes from the Supreme Court | February 22nd, 2024

Regular Meeting

The Supreme Court of the Student Government Association of Tennessee Tech met at 6:55pm on February 22nd, 2024, in the Center for Student Engagement conference room. Chief Justice Bryson Lee was present and presiding. Chief Justice Lee swore in Justice Magpayo and Justice Rogers. Attorney General Tidwell took the roll, and a quorum was established. As the minutes for the January 25th and February 6th meetings had been provided to all members in the past, Justice Martin **MOVED** that they be consider read with unanimous consent. The motion **ADOPTED WITHOUT OBJECTION**. The minutes dated January 25th stand approved. The minutes dated February 6th stand approved. Chief Justice Lee announced that signups for the SOLO concert were now available for those looking to work the event.

Attorney General Tidwell provided announcements about Dr. Ben Stubbs recommendations for modifying the SOLO Events Committee that were presented at the February 19th Senate meeting.

Chief Justice Lee announced that the Constitutional Committee is meeting every Friday at 3:30pm to discuss a new constitution draft and that they would enjoy any visitors with input on the draft.

Chief Justice Lee announced that the parking pass chance drawing sponsored by the Court had concluded and that the winner had received their gold parking pass.

Chief Justice Lee announced that Alternate Associate Justice Blake Garrett had resigned from the Supreme Court and that there are two remaining vacancies on the Court in both Alternate Associate Justice positions.

Chief Justice Lee opened a discussion on whether the next meeting should instead be held at the Caf so that Justices could get a better understanding of the options available to people on campus.

Chief Justice Lee asked for those available to help distribute flyers to hang up on campus.

Pursuant to the orders of the day, Chief Justice Lee declared the Supreme Court adjourned until after the adjournment of the Student Citation Appeals Committee on March 5th, 2024.
